the Gaol of said County, southerly along the River Saint John, as far as Upham's Creek, so called, and to extend westerly or back from said River one mile.

CAP. XVI.

An Act to amend an Act, intituled An Act to provide for the collection of the Revenue of this 6 W. 4, c. 4. Province.

Passed 11th April 1843.

HEREAS it is deemed expedient to provide for the warehousing of all Preamble. Goods and Merchandize subject to Provincial duty, and entered at the ' Ports or Districts of Saint John, Saint Andrews, Saint Stephen, Fredericton and ' Woodstock, in lieu of giving Bonds for the payment of the duties thereon, upon ' the first entry of such Goods and Merchandize ;'

I. Be it enacted by the Lieutenant Governor, Legislative Council and Assembly, 6 W. 4, c. 4, s. 7, That the seventh, twenty eighth and twenty ninth Sections of an Act made and regards goods en-passed in the sixth year of the Reign of His late Majesty William the Fourth, tered at certain ports, repealed, ex-intituled An Act to provide for the collection of the Revenue of this Province, so far even as of duties. as regards Goods entered at the Ports or Districts of Saint John, Saint Andrews, Saint Stephen, Fredericton and Woodstock, shall be and the same are hereby repealed, except so far as relates to any arrears of Duties which shall have become due and payable, or Duties for which Bonds shall have been given under or by virtue of the provisions of the said Act.

II. And be it enacted, That the Owner, Consignee or person entering any Goods Duties on goods eninwards at the aforesaid Ports or Districts of Saint John, Saint Andrews, Saint Ports to be paid Stephen, Fredericton and Woodstock liable to duty, shall at the same time pay down, except when warehoused. down all Duties, except in cases of warehousing the Goods, and the Treasurer, Deputy Treasurer or other proper Officer shall thereupon grant his Warrant in writing for the unlading and warehousing of such Goods.

III. And be it enacted, That so much of the fiftieth and fifty first Sections of 6 w. 4, c. 4, s. 50, the said Act as gives an option to the Importer or Consignee of any Goods en-tered at the said Ports or Districts of Saint John, Saint Andrews, Saint Stephen, when amonnting Fredericton and Woodstock, to give a Bond for the Duties when the same may to \$25, repealed. amount to twenty five pounds and upwards, be and the same are hereby repealed.

IV. And be it enacted, That this Act shall continue and be in force until the Limitation. eighth day of March which will be in the year of our Lord one thousand eight hundred and forty six.

CAP. XVII.

An Act to repeal an Act intituled An Act relating to the Market in Fredericton, and to make other provisions relating thereto.

Passed 11th April 1843.

HEREAS an Act made and passed in the fifth year of the Reign of Preamble. 'Her present Majesty Queen Victoria, intituled An Act relating to the 5 V. c. 19. " Market in Fredericton, has been found ineffectual for the purposes for which it

' was intended ;'

I. Be it therefore enacted by the Lieutenant Governor, Legislative Council and 5V. c. 19, repealed. Assembly, That the said hereinbefore recited Act be, and the same is hereby repealed.

II. And be it enacted, That it shall and may be lawful for the Justices of the Justices in Session Peace for the County of York at any General Sessions of the Peace to be holden may make regula-
