CAP. XXV.

An Act in addition to an Act, intituled An Act for erecting a Parish in the City of Saint 29 G. 3, c. 1. John, and incorporating the Rectors, Church Wardens and Vestries of the Church of England, in the several Parishes in this Province.

B E it enacted by the Lieutenant Governor, Legislative Council and Assem- A Clergyman duly bly, That any Clergyman duly inducted into the Rectory of any Church Rectory of any in any Parish within this Province, shall be deemed and taken to be the Rector Church to be deemed the Rector of any other Church is any other for the rector of of any such other Church or Churches in the same, or in any other Parish or of any other Parishes when he shall have received Letters of Institution from the Bishop of which he shall rethe Diocese, giving him the spiritual charge of the same, and shall have and be ceive Letters of Inentitled to all the powers and authorities within the Parishes in which the several Churches are situated, which are given to Rectors by an Act, intituled An Act 29 G. 3, c. 1. for erecting a Parish in the City of Saint John, and incorporating the Rectors, Church Wardens and Vestries of the Church of England in the several Parishes in this Province, so long as he shall be continued in such spiritual charge; provided Not to authorize the always, that nothing contained in this Act shall authorize or empower the Cler-gyman receiving such Letters of Institution, to fell, cut down or take away or Glebe, without license from the otherwise dispose of the Timber or Wood which may be growing or be on any Bishop. lot or lots of Land which constitute the Glebe of the Church of which he may thereby have the spiritual charge, without express license shall be given him so to do in writing, by the Bishop of the Diocese.

CAP. XXVI. An Act to revive certain Acts relating to the prevention of the importation and spreading of U.C. I. **B**E it enacted by the Lieutenant Governor, Legislative Council and Assem-bly, That an Act made and passed in the first year of the Reign of His 1 W. 4, c. 40, and late Majesty King William the Fourth, intituled An Act to make more effectual provision for preventing the importation and spreading of Infectious Distempers within the Towns and Settlements in the Counties of Charlotte and Northumberland, and also an Act made and passed in the second year of the Reign of His late Majesty 2 w. 4, c. 17, King William the Fourth, intituled An Act to amend an Act passed in the first revived. year of the Reign of His present Majesty King William the Fourth, intituled 'An Act to make more effectual provision for preventing the importation and spreading of Infectious Distempers within the Towns and Settlements in the Counties of Charlotte and Northumberland,' be and the same are hereby revived and declared to be in full force during the continuance of this Act.

II. And be it enacted, That the provisions of the Acts herein recited, and by Acts 1 W. 4, c. 40, this Act revived, shall extend and be construed to extend to the Counties of extended to Glou-cester and Resti-Gloucester and Restigouche. gouche.

III. And be it enacted, That this Act shall continue and be in force until the Limitation. first day of May which will be in the year of our Lord one thousand eight hundred and forty six.
