Be it therefore enacted by the Licutenant Governor, Legislative Council and Au annual assess-Assembly, That it shall and may be lawful for the Justices of the Peace of the £750, with expen-City and County of Saint John, at any General Sessions of the Peace to be holden County Contingen-for the said City and County, to order and direct an assessment for the current cies, authorized. year, not exceeding the sum of seven hundred and fifty pounds, together with the expenses of assessing and collecting the same, for the purpose of defraving the contingent expenses of the said County, to be assessed, levied, collected and paid in the same manner as any County or Parish Rates are assessed, levied, collected and paid, under and by virtue of any Act or Acts of Assembly made or to be made for that purpose; and when received, to be paid over by the Collector into the hands of the County Treasurer, to be disbursed by him from time to time on the orders of the said Justices in any General Sessions to be made for the purpose of paying such County Contingencies.
