CAP. XV.

An Act further to alter and amend the Act to provide for the erection of an Alms House and Work House, and to establish a Public Infirmary in and for the City and County of Saint John.

Passed 26th April 1950.

BE it enacted by the Lieutenant Governor, Legislative Council and Assem-Commissioners of bly, That the Commissioners of the Alms House and Work House for and Work House the City and County of Saint John, heretofore appointed or hereafter to be to be subject to the appointed under the provisions of an Act made and passed in the first year of the General Sessions of the Pearce. Reign of Her present Majesty, intituled An Act to provide for the erection of an IV. 17. Alms House and Work House, and to establish a Public Infirmary in and for the City and County of Saint John, shall be subject to the order and control of the General Sessions of the Peace for the City and County of Saint John, in the same manner and to the same extent as any Overseers of the Poor in any Parish in this Province now are subject to any order of the General Sessions of the County to which such Parish may belong; and that the provisions of the second section revisions et a v. of an Act made and passed in the ninth year of the Reign of Her present Ma- 130, s. 2, extended to the said Comjesty, intituled An Act relating to County and Parish Officers in the City and missioners. County of Saint John, shall be extended to and are hereby declared to apply to the said Commissioners of the said Alms House and Work House in the same manner as if the said Commissioners were Parish or County Officers appointed by the Justices of the Peace for the City and County of Saint John.

II. And be it enacted, That none of the said Commissioners shall receive any No Commuscourt compensation or allowance directly or indirectly for his services as such, nor sation for services. shall any of them be capable of holding any office, place or employment in, about emolument not be or connected with the said Alms House and Work House, for or by means of interested in any which any salary, fee, emolument, compensation or perquisite can be derived, nor with the bease. shall any Commissioner either by himself or his partner be engaged or interested in any way whatever, either as security or otherwise in any contract for or on account of the said Alms House and Work House, or in furnishing any supplies,

goods, materials, provisions or articles whatever for the use thereof.

Magistrates of the City and County childed to visit the House and inspect the details.

III. And be it enacted, That all the Magistrates in and for the City and County of Saint John shall have the right to visit the said Alms House and Work House for any purpose connected with the good management of the same, and shall have III. And be it enacted, That all the Magistrates in and for the City and County full power and authority to examine and inspect all the details of management and indoor economy of the same, and also into the character, conduct and employment of each and every of the inmates.
