to be laid before the General Assembly at the next Session, and the other copy to be filed in the Office of the Clerk of the Peace in the respective Counties, for public information.

IV. And be it enacted, That the before mentioned sums of money shall be Money to be paid by the Treasurer paid by the Treasurer out of the moneys in the Treasury, or as payments may be by Warrant. made at the same, by Warrant of His Excellency the Lieutenant Governor or Administrator of the Government for the time being, by and with the advice and

consent of Her Majesty's Executive Council.

V. And be it enacted, That the said Commissioners intrusted with the expen-Commissioners. diture of the said several and respective sums of money, shall for their time and trouble be allowed to retain at and after the rate of five per centum out of the said money so intrusted to them respectively, together with a reasonable compensation for actual labour and work performed by them on the said several Roads and Bridges.

VI. And be it enacted, That the said Commissioners shall expend the said Money to be several and respective sums of money on the Roads on or before the first day of before the first of October; provided always, that nothing herein contained shall extend or be con-October. strued to extend to prevent any Commissioner from expending moneys after the first day of October, when it shall be necessary to expend the same for building Bridges, removing rocks, stumps, trees, or other obstructions.

VII. And be it enacted, That none of the before mentioned sums of money, No money to be or any part thereof, shall be laid out or expended in the making or improving any tions not recorded. alteration that may be made in any of the said Roads, unless such alterations shall have been first laid out and recorded.

VIII. And be it enacted, That all persons who may be appointed Commis- Commissioners to sioners for the expenditure of money hereinbefore granted, and before entering due performance of duties. upon the duties of his office, shall respectively enter into a Bond to Her Majesty, Her Heirs and Successors, to the satisfaction of the Executive Government, for the due performing his duty as such Commissioner, and the faithful expenditure of and due accounting for such moneys as shall come into his hands as such Commissioner.

CAP. XV.

An Act to revive and continue certain Acts of Assembly providing for expenses of the Legislature. Passed 30th April 1851.

E it enacted by the Lieutenant Governor, Legislative Council and Assembly, Acta 3 V. c. 69, & That an Act made and passed in the third year of the Reign of Her present revived and continued. Majesty, intituled An Act further to provide for the expenses of the Legislature; continued. also an Act made and passed in the tenth year of the same Reign, intituled An Act to provide for the expenses of the Speaker and Members of the House of Assembly, be and the same are severally revived and continued during the continuance of the present House of Assembly and no longer.

CAP. XVI.

An Act to consolidate and amend the Laws providing for the maintenance of Light Houses in the Bay of Fundy. Passed 30th April 1851.
