'Courts have been regularly holden, and the other requirements of the said Act 'have been duly performed, and it is necessary to legalize the same, and also to 'revive and continue the said Act:'

Be it therefore enacted by the Lieutenant Governor, Legislative Council and

Assembly, as follows:—

1. Every act, matter and thing done or committed within the meaning and Every thing done pursuant to the provisions of the Act of Assembly passed in the ninth year of c. 57, and things Her present Majesty's Reign, intitated An Act relating to Circuit Courts in this before or since the Province and to provide for the travelling expenses of the Judges holding such expiration of the Act, confirmed. Courts, and every act, matter and thing which may be necessary to complete what may have been begun within the provisions aforesaid, either before or since the expiration of the said Act, are hereby declared to be as valid, legal and effectual as if the said recited Act had been regularly continued.

2. The said recited Act is hereby revived and continued and shall be in force 9 V. c. 57, revived until the first day of May in the year of our Lord one thousand eight hundred and continued. and fifty five.

An Act to prevent the traffic in Intoxicating Liquors.

Passed 7th April 1852.

'as a beverage is the cause of a very large proportion of the ills that 'affect communities in producing frime, poverty, disease and demoralization: 'And whereas it is the duty of all Governments to legislate for the happiness, comfort and prosperity of the people;
