and passed in the eleventh year of the Reign of Her present Majesty, intituled An Act to authorise the Rector, Church Wardens and Vestry of Saint Mary's Church, 11 7. c. 44. in the Parish of Richibucto, to sell certain Lands granted to the said Corporation, and vest the proceeds in other Lands;"-and to vest the sum so received in other lands for the use and purpose of a Glebe for the Rector of said Church.

CAP. L.

An Act relating to the Saint Andrews and Quebec Rail Road Company. Passed 3rd May 1853.

BE it enacted by the Lieutenant Governor, Legislative Council and Assembly, as follows:-

1. So much of the fourth section of the Act made and passed in the fourteenth 14, V. c. 35, s. 4, year of the Reign of Her present Majesty, intituled An Act to facilitate the construction of a Railway from Saint Andrews to Quebec, as authorises the Legislative Council and Assembly, by joint resolution, to appoint two Directors, who shall have the same power and authority as any other Directors chosen under the Act of incorporation; together with the Act made and passed during the present Session, intituled An Act to amend the Act to facilitate the construction of a Railway 16 V. c. 3. from Saint Andrews to Quebec, be and the same are hereby repealed.

2. The Lieutenant Governor or Administrator of the Government for the time Governor in Council to appoint being, in Council may, and he is hereby required annually, or from time to time, as from time to the optimistic occasion shall require, to appoint two Directors in the Saint Andrews and Quebec Company. Rail Road Company, who shall have the same power and authority as any other Directors chosen by the said Company under their Acts of incorporation; and in case of such Directors, or either of them, refusing or neglecting to act, or for other good cause, to cancel such appointment, and another or others to appoint in his or their stead.

CAP. LL

An Act to extend the Charter of the President, Directors and Company of the Commercial Bank of New Brunswick.

Passed 3rd May 1853.

DE it enacted by the Lieutenant Governor, Legislative Council and Assembly, D as follows :--

The Charter heretofore made and granted to the President, Directors and Charter of the Commercial Bank Company of the Commercial Bank of New Brunswick, by Letters Patent under determined 10th August 1936, extended to the Great Seal of this Province, bearing date the sixteenth day of August in the 16th August 1876. year of our Lord one thousand eight hundred and thirty four, and all matters and things therein contained, be and the same are hereby continued and declared to be in full force and effect to all intents and purposes, till the sixteenth day of August which will be in the year of our Lord one thousand eight hundred and seventy six.

CAP. LII.

An Act to increase the Capital Stock of the Saint Stephen's Bank, in the County of Charlotte. Passed 3rd May 1853.

THEREAS from the increase of business and trade in Saint Stephens, Presente. ' and from the limited Capital of the Saint Stephen's Bank, it becomes ' expedient to increase the Capital Stock of the same;'

Be it enacted by the Lieutenant Governor, Legislative Council and Assembly, as follows :---
