of Title VI of the Revised Statutes, and so much of an Act made and passed in the seventeenth year of the Reign of Her Majesty Queen Victoria, intituled An Act to alter and amend the Act providing for the establishment of Municipal Authorities in this Province, as is inconsistent with the provisions of this Act, are hereby repealed; but all the other provisions of the said recited Act shall remain in force.

2. When there are several polling places in a Parish, a meeting to consider the propriety of incorporating any County shall be held at each polling place, and the Sheriff shall prescribe the place the Town Clerk shall attend, being the nearest to his residence, and appoint a fit person to attend any other place.

3. The Collector of Rates shall furnish the list required by the fifth Section of the said recited Act for every polling district in the Parish, in the manner and subject to the penalties mentioned in the said Section.

4. If a majority of the Rate payers upon Property in the County vote for the Incorporation, the Sheriff shall certify the same to the Governor in Council, who shall grant a Charter therefor.

CAP. IV.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :---

1. That there be allowed and paid out of the Treasury of the Province to the President of the Legislative Council the sum of fifty pounds for the present Session of the General Assembly, and the sum of one hundred and fifty pounds for each and every future Session of the General Assembly.

2. That there be allowed and paid out of the said Treasury to each and every Member of the Legislative Council, for defraying the expenses of attending in General Assembly, the sum of twenty shillings per diem for the attendance of the Legislative Council, to be certified by the President thereof.

3. That there be allowed and paid out of the said Treasury to the Speaker of the House of Assembly the sum of fifty pounds for the present Session of the General Assembly, and the sum of one hundred and fifty pounds for each and every future Session of the General Assembly.

4. That there be allowed and paid out of the said Treasury to each and every Member of the House of Assembly, for defraying the expenses of attendance in General Assembly, the sum of twenty shillings for each and every day's attendance of each Member of the House of Assembly, to be certified by the Speaker.

5. That for defraying the travelling charges of the Members of the Legislative Council, and also of the House of Assembly. there be allowed and paid out of the said Treasury the sum of twenty shillings per diem to each and every Member, allowing twenty miles for each day's travel, to be certified by the President of the Legislative Council for the Members of the Legislative Council, and by the Speaker of the House of Assembly for Members of the House of Assembly.

6. That the several sums hereinbefore mentioned shall be paid by the Treasurer, by Warrant or Warrants of the Governor in Council, out of any moneys now in the Treasury, or as payments may be made at the same.

7. That this Act shall continue and be in force during the continuance of the present General Assembly, and no longer.
