and Parishes in their respective Counties; and in case no return of such Commissioners for any Parish or Parishes shall have been made, the Clerk of the Peace shall certify the same, and persons shall be appointed by the Governor in Council to expend the money in such Parishes for which no Commmissioners are certified to have been elected, in the same manner as if this Act had not been passed.

- 4. No such moneys shall be drawn from the Treasury without a certificate from such Commissioner or Commissioners respectively, or the majority of them, filed in the Office of the Secretary of the Province, that the amount has been duly expended as by law directed; nor until such Commissioners shall give bonds, to be prescribed by the Government.
- 5. This Act shall not come into operation until the first day of October one thousand eight hundred and fifty five.
 - 6. This Act shall not affect incorporated Counties.

To the Infant School in the City of Fredericton the sum of fifty pounds towards the support of that institution.

To Michael White the sum of one hundred pounds for his services as Clerk in the office of Clerk of the Pleas.

To the Lieutenant Governor the sum of fifty pounds in aid of the Newcastle Grammar School taught by Robert Falkner, A.B., for the year ending October one thousand eight hundred and fifty five; to be paid on its being certified to the satisfaction of the Governor in Council that such School has been efficiently taught.

To the Justices of the Peace for the County of Westmorland the sum of four hundred pounds to aid in building a new Gaol in that County; the said sum not to be drawn from the Treasury until it be certified to the satisfaction of the Government that a similar sum has been assessed upon the County and duly paid to the officer entitled to receive the same.

To the Trustees of Schools in the Parish of Addington, in the County of Restigouche, the sum of fifty pounds in lieu of the ordinary allowance, to enable them to keep a superior School at Campbellton in said County; the same not to be drawn until it is certified to His Excellency the Lieutenant Governor in Council that such School has been taught.

To His Excellency the Lieutenant Governor the sum of two thousand pounds to reimburse advances made for repairs of Roads and rebuilding and repairing Bridges after the flood in November last.

To His Excellency the Lieutenant Governor a sum not exceeding fifty pounds towards the support of a School for the education of the Indian children at Indian Village.

To His Excellency the Lieutenant Governor the sum of fifty pounds for the support of an African School in Loch Lomond, in the Parish of Simonds.

To Rachael Martin, of Fredericton, an aged and valuable Instructress of Youth, the sum of twenty pounds.

To Jane Payne, a licenced second class Teacher, the sum of eighteen pounds for having taught a School in the City of Fredericton for a period of twelve months ending the first of May one thousand eight hundred and fifty four.

To Duncan Stewart, Tide Waiter, for services as Gauger and Weigher, the sum of ten pounds ten shillings for services rendered in the year one thousand eight hundred and fifty four.

Fraser and Company, of Miramichi, in running a Packet between Chatham, Bedeque, and Charlottetown, Prince Edward Island, for the present year; the same not to be drawn until it be satisfactorily certified to the Government that they have run a vessel on the route in every way fit for the purpose during open water.

To John Hawes and Company, of Miramichi, the sum of forty pounds seventeen shillings and six pence to refund them duties twice paid on a cargo of timber and lumber, agreeably to the Report of the Committee of Trade.

To Alexander M. Inches, of Saint Stephen, in the County of Charlotte, the sum of sixty eight pounds nine shillings and ten pence to refund duties paid on a quantity of goods shipped from Saint John in October one thousand eight hundred and fifty three in a vessel which was cast away, and the goods entirely lost.

To John Richards, of Fredericton, the sum of thirty nine pounds seventeen shillings and six pence to reimburse duties paid on goods destroyed by the Great Fire at Fredericton in July last.

To His Excellency the Lieutenant Governor a sum not exceeding one hundred and fifty pounds for the purpose of procuring a Steam Engine to be used in the Pile Driving Machine now in the course of erection.

To the Trustees of the Roman Catholic School in Fredericton the sum of one hundred pounds in aid of that institution.

To the Board of Trustees of the Wesleyan Academy at Sackville the sum of three hundred pounds in support of the female branch of said institution.

To His Excellency the Lieutenant Governor a sum not exceeding twenty five pounds, in aid of individual subscription, towards the erection of a Wharf in the River Saint John at the termination of the division line of lands owned by William Carpenter and William Shaw in the Parish of Wickham, Queen's County; the same being in lieu of a Grant of forty pounds made last Session as follows: "To His Excellency the Lieutenant Governor or Administrator of the Government for the time being, the sum of forty pounds to complete the Wharf at Robert Golding's landing, Parish of Wickham, Queen's County; the same not to be drawn from the Treasury until a satisfactory certificate is received by the Executive Government from a Commissioner to be appointed for the purpose, that a similar sum has been raised and paid from individual subscriptions, and has been expended towards such erection;" which said last mentioned Grant is hereby cancelled.

To Deline Peltitier the sum of nine pounds to compensate her for teaching a School six months commencing the first day of February one thousand eight hundred and fifty three, and ending the first day of August of the same year, previous to obtaining her licence.

To Letty Bell, Widow of an old Soldier of the Revolutionary War, the sum of ten pounds.

To the Governor and Trustees of the Madras School the sum of four hundred pounds towards the support of that institution.

To His Excellency the Lieutenant Governor the sum of one hundred and fifty pounds towards the support of the Roman Catholic School established in the City of Saint John.

To His Excellency the Lieutenant Governor the sum of thirty pounds, in aid of individual subscription, towards the support of the Free School in the Parish of Portland, County of Saint John; the same to be expended by the Board of Commissioners of the Roman Catholic School in the City of Saint John.
