AN ACT to Provide for the Contingent Expenses of the Legislature, during the Present Session.

[Passed 4th August, 1855.]

WHEREAS it is expedient to provide for the Contingent Expenses of Preamble. the Legislature of this Colony during the present Session :

Be it therefore enacted by the Governor, Legislative Council and Assembly, of Newfoundland, as follows :----

That from and out of such Monies as shall from time to time remain in the hands of the Receiver General, and unappropriated, there be granted £5.147 9s. 2d, to Her Majesty the Sum of Five Thousand One Hundred and Forty Seven the Contingent Pounds Nine Shillings and Two Pence, to be applied towards remu- Expenses of the nerating the Officers of the Legislature for their services, and towards Legislature; defraying the Contingent Expenses of Her, Majesty's Council and the House of Assembly during the present towards Legislature;
