## CAP. XIV.

An Acr to provide for the Contingent Expenses of the Legislature.

## [Passed 27th March, 1862,]

WHEREAS it is expedient to provide for the Contingent Expenses of the Legislature of this Colony :

Proambie.
Be it therefore enacted by the Governor, Legislative Council, and As: sembly, in Legislative Session convened :

That from and out of such Monies as shall from time to time remain in the hands of the Receiver General, and unappropriated, there be granted $\begin{gathered}\text { Contingencies } \\ \text { E5967 } \\ \text { I7 } \\ \text { Sd. }\end{gathered}$ to Her Majesty, Her Heirs and Successors, the Sum of Five Thousand Nine Hundred and Sixty-seven Pounds Seventeen Shillings and Three Pence, to be applied towards remanerating the Officers of the Legislature for their Services, and towards defraying the Contingent Expenses of the Legislative Council and House of Assembly, as follows:
