" ment of the growth and cultivation of Hemp within this Province, and the exportation " thereof," as also an Act paffed in the fifty fecond year of His Majesty's Reign, intituled, " An Act for granting to His Majesty a certain Sum of Money further to encourage the " growth and cultivation of Henip in this Province, and for other purpofes."

HEREAS the feveral Acts now in force in this Province granting to His Majefty a certain Sum of Money for the encouragoment of the growth and cultivation of Hemp are not found beneficial in proportion to the expence incurred by them : Be it therefore enacted by the King's Moft Excellent Majefty, by and with the advice and confent of the Legiflative Council and Affembly of the Province of Upper Canada, conffituted and allembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, intituled, " An Act to repeal certain parts of an ACt passed in the fourtcenth year of His Majesty's Reign, intituled, "An ACt for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the faid Province : and by the authority of the fame, That an Act passed in the forty fourth year of His Majefty's Reign, intituled, "An Act for granting to His Majefty a certain 11, and 52 Geo.
