WHEREAS, from the great extent of the Eastern District of this Province, the Inhabitants of the Counties of Prescott and Russell, in the said District experience much inconvenience in attending His Majesty's Courts of Justice at present established, Be it enacted by the King's most Excellent Majesty by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled, by virtue of and under the authority of an Act passed in the Parliament of Great Britain entitled, " an Act to repeal certain parts of an Act, passed in the fourteenth year of His Majesty's Reign, entitled an Act for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the said Province" and by the authority of the same, that from and after So much of the 35th the passing of this Act, so much of an Act, passed in the thirty-eighth year of His George 3d as directs Majesty's Reign, entitled, "an Act for the better division of this Province" as dithat the Counties of rects that the Counties of Russell and Prescott, shall form part of the Eastern Dis-Prescott and Russell the Russell the Russell and Prescott, shall form part of the Eastern Disshall form part of the trict shall be repealed, and the same is hereby repealed accordingly.
