W HEREAS it is necessary to repeal part of, and to amend and extend the provisions of an Act passed in the second year of the Reign of His present Majesty, entituled "An Act to repeal the laws now in force relative to the

#### MOST GRACIOUS SOVEREIGN,

WHEREAS the Rev. Robert Addison has for thirty years, with zeal and piety, performed the duties of Chaplain to the Honorable the House of Assembly; and whereas, from his advanced age and long services, it is expedient to grant him, the said Rev. Robert Addison, a Pension during his life; Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper-Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, entituled "An Act to repeal certain parts of an Act passed in the fourtcenth year of His Majesty's Reign, entituled 'An Act for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the said Province, and by the authority of the same, That out of the rates and duties already raised, levied, and collected, or hereafter to be raied, levied, and collected, to and for the uses of this Province, and in the hands of the Receiver General 150 granted to unappropriated, there be granted to the said Rev. Robert Addison for and the Rev. Robert during his natural life, the sum of Fifty Pounds annually, which said sum of Fifty Pounds shall commence and become payable from and after the passing of this Act.
