CHAP. XXVIII.

AN ACT granting to His Majesty a sum of Money in aid of the crection of an Hospital in or near the Town of Kingston.

[Passed 28th January, 1832.]

MOST GRACIOUS SOVEREIGN.

WHEREAS it is necessary to provide for the erection and establishment of an Asylum for the destitute Sick within this Province: And Preamble. whereas the Inhabitants of the Town of Kingston have subscribed a large sum of money towards the erection of an Hospital in or near that place, and have prayed that an additional sum may be granted from the Public Revenues in aid of that object, may it please Your Majesty that it may be enacted: And be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled by virtue of and under the authority of an Act passed inthe Parliament of Great Britain, entitled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, entitled 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America,' and to make further provision for the Government of the said Province," and by the authority of the same, That from and out of the Rates and Duties raised, levied and collected, or hereafter to be raised, levied and collected, there be Majesty in aid of granted to His Majesty, His Heirs and Successors, the sum of Three the Erection of an Thousand Pounds, of lawful money, which said sum of Three Thousand Kingston. Pounds shall be applied in aid of the erection and completion of an Hospital in or near the Town of Kingston, for the reception of the destitute Sick: Provided always, that the said sum of Three Thousand by instalments of Pounds shall be advanced and paid by equal annual Instalments of One £1000 per annum. Thousand Pounds,—the first instalment to be advanced and paid on the first day of May next after the passing of this Act, and the two remaining Instalments on the first day of May in each of the two succeeding years.

II. And be it further enacted by the authority aforesaid, That John Commissioners Macaulay, James Sampson, and Edmund Westrop Armstrong, all of appointed for superintending the Kingston aforesaid, be Commissioners for superintending and managing erection of the the erection and completion of the said Hospital, and for purchasing, Building. or otherwise obtaining, choosing and determining, the site thereof.

Money to be paid by Warrant, and accounted for through the Lord: of the Treasury. III. And be it further enacted by the authority aforesaid, That the said sum of Three Thousand Pounds shall be paid by the Receiver General of this Province in discharge of such Warrant or Warrants as shall for that purpose from time to time be issued by the Governor, Lieutenant Governor or Person Administering the Government of this Province; and shall be accounted for to His Majesty, His Heirs and Successors, through the Lords Commissioners of His Majesty's Treasury for the time bieng, in such manner and form as His Majesty, His Heirs and Successors, shall be graciously pleased to direct.

CHAP. XXIX.

AN ACT to grant a Sum of Money to His Majesty in aid of the York Flospital.

[Passed 28th January, 1832.]

MOST GRACIOUS SOVEREIGN.

Preamble,

WHEREAS the great utility of the Public Hospital of the Town of York has been further exemplified during the year past by the attention paid, and Medical and Surgical assistance afforded to destitute distressed Emigrants and others, and it is desirable to afford further aid to the said Institution; We therefore beseech Your Majesty that it may be enacted, And be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, entitled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, entitled 'An Act for making more effectual provision for the Government of the Province of Quebec, in North America,' and to make further provision for the Government of the said Province," and by the authority of the same, That from and out of the rates and duties already raised, levied and collected, or hereafter to be raised levied and collected, and unappropriated, there be granted to: His Majesty the sum of One Hundred and Fifty Pounds of lawful Money of this Province, to be held by His Excellency the Lieutenant Governor, or Person Administering the Government of this Province for the time being, in trust to be applied to the use and benefit of the said Hospital.

II. And be it further enacted by the authority aforesaid, That the Money hereby granted shall be paid by the Receiver General in discharge
