declared by the Governor, Lieutenant Governor, or Person Administering the Government of this Province, by and with the advice of His Majesty's Executive Council, in pursuance of the power in him vested by this Act, or shall wilfully resist or obstruct the said Health Officers in the execution of their duties, such person or persons, on being convicted of such wilful disobedience, or violation of such rules and regulations, or of resistance to the said Health Officers, before two or more of His Majesty's Justices of the Peace for the District where such offender or offenders reside, shall forfeit and pay a fine not less than Twenty Shillings, nor more than Twenty Pounds, which said fine shall and may be levied and collected by seizure and sale of such offender or offenders Goods and Chattels, under and by virtue of a Warrant issued under the Hand and Seal of the Justices before whom such offender or offenders shall or may have been convicted, and shall be paid into the hands of His Majesty's Receiver General, to and for the public uses of this Province, and be accounted for through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form as His Majesty shall be pleased to direct.

CHAP. XLIX.

AN ACT for granting to His Majesty a Sum of Money towards defraying the expense of the Civil Administration of the Government of this Province

[Passed 13th February, 1833.].
