

## CHAP. LI.

*AN ACT granting a further sum of Money for the Completion of the Parliament Buildings.*

[ Passed 13th February, 1833.]

MOST GRACIOUS SOVEREIGN :

Preamble.

**W**HEREAS by an Act passed in the seventh year of His late Majesty's Reign entitled, "An Act to authorise the raising by Debenture a sum of Money to be applied in erecting Buildings for the use of the Legislature," the sum of Seven Thousand Pounds hath been raised and expended : *and whereas* it appears from the Report of the Commissioners appointed for Superintending the erection of the said Buildings that an additional sum is required for their completion : May it therefore please Your Majesty that it may be enacted, *And be it enacted* by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, entitled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, entitled 'An Act for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the said Province,'" and by the authority of the same, That from and out of the Rates and Duties already raised, levied and collected, or hereafter to be raised, levied and collected, and unappropriated, there be granted to Your Majesty, Your Heirs and Successors, the sum of Three Thousand Five Hundred Pounds ; which said sum of Three Thousand Five Hundred Pounds shall be appropriated and applied in completing the said Buildings, in improving or altering the same, in enclosing and levelling the ground appertaining thereto, and discharging any claims for work done to the said Building, which the Commissioners hereinafter named shall deem just.

£3,500 granted to His Majesty for completing the Parliament Buildings.

Commissioners appointed.

II. *And be it further enacted by the authority aforesaid*, That the Honorable Alexander McDonell, David A. Macnab, and James FitzGibbon, Esquires, be Commissioners to carry the provisions of this Act into effect, and also for the purpose of examining the Accounts of the expenditure under the said recited Act : *Provided always, nevertheless*, that if any of the said Commissioners shall die, or shall decline to act as Commissioner under this Act, it shall be in the power of the Governor, Lieu-

tenant Governor, or Person Administering the Government of this Province, to appoint a Commissioner or Commissioners in the room of any one or more of such Commissioners as shall die or refuse to act as aforesaid.

III. *And be it further enacted by the authority aforesaid,* That the monies hereby granted and so applied, shall be accounted for to His Majesty through the Lords Commissioners of His Majesty's Treasury for the time being, in such manner and form as His Majesty, His Heirs and Successors, shall be graciously pleased to direct: and that an account of the expenditure thereof, in detail, shall be submitted to the Legislature at its next Session.

## CHAP. LII.

*AN ACT granting a Sum of Money for the relief of sick and destitute Emigrants at Prescott.*

[Passed 13th February, 1833.]

MOST GRACIOUS SOVEREIGN :

WHEREAS among the great and annually increasing influx of Emigration from the Mother Country to this Province, many persons are found on their arrival at the Port of Prescott, in consequence of fatigue and expense incident to so long a voyage, in a Sickly and Destitute state; *and whereas* humanity directs that some Relief should be afforded to persons of this description over and above what may arise from the Christian feelings and benevolence of the people residing at that place of general disembarkation: May it please Your Majesty that it may be enacted, *And be it enacted* by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, entitled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, entitled 'An Act for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the said Province,'" and by the authority of the same, That out of the Rates and Duties now raised, levied and collected, or which may be hereafter raised, levied and collected, and unappropriated, there be granted to
