

## CHAP. LX.

*AN ACT* granting to His Majesty a sum of Money for the Improvement of Roads and Bridges in the several Districts of this Province.

[Passed 13th February 1833.]

MOST GRACIOUS SOVEREIGN:

**WHEREAS** it is desirable and necessary to afford aid towards repairing Roads and Bridges in the several Districts of this Province: May it therefore please Your Majesty that it may be enacted, *And be it enacted* by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Assembly of the Province of Upper Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of Great Britain, entitled "An Act to repeal certain parts of an Act passed in the fourteenth year of His Majesty's Reign, entitled 'An Act for making more effectual provision for the Government of the Province of Quebec in North America, and to make further provision for the Government of the said Province,'" and by the authority of the same, That it shall and may be lawful for the Governor, Lieutenant Governor, or Person Administering the Government of this Province, to authorize and direct His Majesty's Receiver General of this Province to raise by Loan from any person or persons, Bodies Politic or Corporate, who may be willing to advance the same upon the credit of the Government Bills or Debentures authorized to be issued under this Act, a sum of Money not exceeding Twenty Thousand Pounds, at a rate of Interest not exceeding Five per Centum per Annum, to be applied to the said Roads and Bridges.

Preamble.

£20,000 may be raised by loan to be applied towards the improvement of Roads and Bridges.

Receiver General to Issue Debentures.

II. *And be it further enacted by the authority aforesaid,* That it shall and may be lawful for the Receiver General for the time being to cause any number of Debentures to be made out for any such sum or sums of Money, not exceeding in the whole the said sum of Twenty Thousand Pounds, as any person or persons, Bodies Politic or Corporate, shall agree to advance on the credit of the said Debentures; which Debentures shall be prepared and made out in such manner and form as His Majesty's Receiver General shall think most safe and convenient, and that for each Loan or advance a Debenture shall issue, bearing date at the day on which the same shall be actually issued, conditioned for the payment of the said sum of Twenty Thousand Pounds, or such part

thereof as shall be actually received, and redeemable at a period not exceeding twenty years, and which Debenture or Debentures shall and may be signed by the said Receiver General of this Province for the time being.

III. *And be it further enacted by the authority aforesaid,* That the Receiver General of this Province for the time being, shall before each Session of the Parliament of this Province transmit to the Governor, Lieutenant Governor, or Person Administering the Government of this Province, a correct account of the numbers, amounts and dates of the different Debentures which he may have issued under the authority of this Act, of the amount of the Debentures redeemed by him and the interest paid thereon respectively, and also of the amount of the Debentures outstanding and unredeemed at the periods aforesaid, and of the expenses attending the issuing the same to be laid before the Legislature of this Province.

Receiver General to make a Report of Debentures issued, to be laid before the Legislature.

IV. *And be it further enacted by the authority aforesaid,* That the Interest growing due upon the said Debentures, shall and may be payable in half yearly periods to be computed from the date thereof, and shall and may be paid on demand by the Receiver General of this Province for the time being, whose duty it shall be to have the same endorsed on each Debenture at the time of payment thereof, expressing the period up to which the said Interest shall have been paid, and shall take receipts for the same from the Persons respectively, and that the Governor, Lieutenant Governor, or Person Administering the Government of this Province, shall after the first day of January and the first day of July in each year, issue Warrants to the Receiver General for the payment of the amount of Interest that shall have been advanced according to the receipts to be by him taken as aforesaid.

Interest when and how to be paid.

V. *And be it further enacted by the authority aforesaid,* That a separate Warrant shall be made to the Receiver General by the Governor, Lieutenant Governor, or Person Administering the Government of this Province for the time being, for the payment of each Debenture as the same may become due and be presented in favour of the lawful holder thereof, and that such Debentures as shall from time to time be discharged and paid off shall be cancelled and made void by the said Receiver General.

Warrants to be issued for the payment of Debentures.

VI. *And be it further enacted by the authority aforesaid,* That if any Person or Persons shall Forge or Counterfeit any such Debenture as

Punishment for forging Debentures.

aforesaid, which shall be issued under the authority of this Act and uncanceled, or any Stamp, Endorsement or Writing thereon or therein, or tender in payment any such Forged Debenture, or any Debenture with such Counterfeit Endorsement or Writing thereon, or shall demand to have any such Counterfeit Debenture, or any Debenture with such Counterfeit Endorsement or Writing thereupon or therein exchanged for ready Money by any Person or Persons who shall be obliged and required to exchange the same, or by any other person or persons whomsoever, knowing the Debenture so tendered in payment, or to be exchanged, or the Endorsement or Writing thereupon or therein to be Forged or Counterfeited with intent to defraud His Majesty, His Heirs and Successors, or the Persons authorised to pay off the same or any of them, or any other Person or Persons, bodies Politic or Corporate, then every such Person or Persons so offending, being thereof lawfully convicted, shall be adjudged a Felon.

Debentures charged upon the public revenues of the Province.

VII. *And be it further enacted by the authority aforesaid,* That all such Debentures, with the Interest thereon, and all the charges incident to or attending the same, shall be and are hereby charged and chargeable upon, and shall be repaid and borne by and out of the Monies that shall come into the hands of the Receiver General to and for the public uses of this Province, and at the disposal of the Legislature thereof.

Interest on Debentures when to cease.

VIII. *And be it further enacted by the authority aforesaid,* That at any time after the said Debentures, or any of them, shall respectively become due according to the terms thereof, it shall and may be lawful for the Governor, Lieutenant Governor, or Person Administering the Government of this Province, if he think proper so to do, to cause a notice to be inserted in the Upper Canada Gazette, requiring all holders of said Debentures to present the same for payment, according to this Act; and if after the insertion of the said notice for three months, any Debentures then payable shall remain out more than six months from the first publication of such notice, all interest on such Debentures shall, after the expiration of the said six months, cease, and be no further payable, in respect of the time which may elapse between the expiration of the said six months and their presentment for payment.

Appropriation of the said sum of £20,000.

IX. *And be it further enacted by the authority aforesaid,* That the said sum of Twenty Thousand Pounds so granted as aforesaid, shall be apportioned to the several Districts of this Province as follows:—

To the Eastern District—the sum of Nineteen Hundred Pounds.

To the Ottawa District—the sum of One Thousand Pounds.	Ottawa, £1,000.

X. *And be it further enacted by the authority aforesaid, That the sum of One Thousand Nine Hundred Pounds hereby granted to the Eastern District, be appropriated and expended as follows :*

Appropriation for the Eastern District how distributed, and by whom to be expended.

*In the County of Glengary.*—On the post road from Dundas Street to the rear of Lochiel, the sum of one hundred and thirty pounds. On the road leading from lot number nineteen, in the fifth concession of Lochiel, to Rigaud, the sum of twenty-five pounds. On the road leading from lot number nineteen, in the fifth concession of Lochiel, towards the River La Grasse, the sum of twenty-five pounds. On the road leading from Dundas Street, East of the Indian Reservation, to the front of Charlottenburgh, the sum of seventy-five pounds. On the nine mile road leading from Martintown to Kenyon, the sum of sixty-eight pounds. On the nine mile road leading from Dundas Street to the South Branch, including the erection of a bridge across the River aux Raisins, the sum of fifty pounds. On the nine mile road leading from Archibald Cameron's, Dundas Street, to the rear of Kenyon, the sum of eighty pounds, six shillings and eight pence. On the nine mile road from John Ban McLennon's, to the rear of Kenyon, the sum of fifty pounds. On the road leading through the Indian Reservation North of the River aux Raisins, the sum of fifty pounds. On the nine mile road North of Dundas Street, between lots numbers twenty-four and twenty-five, to Kenyon, the sum of fifteen pounds. On the nine mile road from the South Branch, to Alexander McGruer's, the sum of fifteen pounds. On the nine mile road leading from Charles Westley's to Dundas Street, the sum of twenty-five pounds. On the nine mile road leading from Dundas Street, in Lancaster, to the third concession of Lochiel, the sum of twenty-five pounds; and that Hugh McGillis, John McGillivray, John Mc-

Lennan, Alexander Chisholm, Donald Catanach, Angus Catanach, and Angus McDonell, Alexander Fraser and Alexander McMartin, be Commissioners for expending the same.

*In the County of Stormont*, the sum of six hundred and thirty-three pounds, six shillings and eight pence, be expended as follows:—On the road between lots six and seven, in the second, third, and fourth concessions of Cornwall, the sum of forty pounds; and that John Cameron, John McDonell, of number ten in the fifth concession of Cornwall, and Alexander McDougall, be Commissioners for expending the same. On the road now in use from Daniel Campbell's junior, in the Township of Cornwall, to the Indian Land, the sum of twenty pounds; and that John Cameron, John Gibson, and Duncan Ferguson, be Commissioners for expending the same. On the road between the second and third concessions of Cornwall, from lot thirteen to twenty-three, the sum of twenty-pounds; and that John Hartle, junior, Nathan Groves, and Joel Eastman, be Commissioners for expending the same. On the road from Cornwall to the rear of Roxborough, the sum of ninety-five pounds; and that Alexander McLean, Esquire, John McDonell, and Duncan McDonell, Esquire, be Commissioners for expending the same. On the road between lots numbers eighteen and nineteen, from the front of the third concession of Cornwall to Dundas Street, the sum of twenty pounds; and that Nadab Eastman, junior, John Milroy, and William McLaughlin, be Commissioners for expending the same. On the road from Henry Empey's to John Roy's, on the St. Lawrence, the sum of thirty-one pounds, thirteen shillings and four pence; and that Alexander McLean, Esquire, John Roys, and Henry Empey, be Commissioners for expending the same. To be applied in opening and establishing a road in the most fit and convenient place for the inhabitants in the West part of the Township of Roxborough, leading to the Saint Lawrence, the sum of thirty pounds; and that Alexander McLean, Esquire, James Roy McDonell, and Angus McDonell, (elder) be Commissioners for expending the same. On the road from the Indian Lands, between the first and second concessions of Cornwall, the sum of forty pounds; and that Guy C. Wood, Esquire, John Chesley, and Martin McMartin, be Commissioners for expending the same. On the road from the front near the Church in Osnabruck, to the rear of Finch, the sum of eighty pounds; and that John Chrysler, Esquire, Joseph Bockus, Esquire, and Michael Empey, be Commissioners for expending the same. From Charlesville to the fifth concession of Osnabruck, the sum of thirty pounds; and that John N. Ault, James Grant, and Philip W. Empey, be Commissioners for expending the same. On the road in that part of Osnabruck called Pleasant Valley, the sum of forty pounds; and that Jeremiah Vanduser,

William Hollester, and John Rambough, be Commissioners for expending the same. On the road from Thomas Maxwell's to the fifth concession of Osnabrock, the sum of forty pounds, and that Thomas Maxwell, Jacob W. Empey, and John Waldroff, be Commissioners for expending the same. On the road from John Dixon's, junior, leading into Finch, to the rear of the third concession, the sum of sixty pounds; and that Robert Dixon, Alexander McMillin, and Hector McLean, be Commissioners for expending the same. On the concession road between Osnabrock and Finch, from the East side of number twenty-two to Roxborough, twenty pounds; and that Alexander McMillan, Donald McIntire, and Hector McLean, be Commissioners for expending the same. To be applied in repairing such Roads in the East part of Roxborough as may be most conducive to the interest of the Inhabitants thereof, the sum of thirty pounds; and that John Montgomery, Benjamin Helmer, and Duncan McCallum, be Commissioners for expending the same. On the road leading from Fraser's Mills, in Cornwall, till it intersects the road leading to the Township of Finch, the sum of thirty-six pounds, thirteen shillings and four pence; and that Simon Fraser, Esquire, Angus McDonell, the elder, and James (Roy) McDonell, be Commissioners for expending the same.

*In the County of Dundas.*—On the nine mile road between lots number four and five, in the second concession of Williamsburgh, the sum of thirty pounds; and that John Piller, junr. and John Weaver, be Commissioners for expending the same. On the nine mile road between lots number eighteen and nineteen in Williamsburgh, the sum of fifty-five pounds; and that George Cook, and George Fetterly, be Commissioners for expending the same. On the nine mile road between lots number twenty-five and twenty-six in Williamsburgh, the sum of thirty-five pounds; and that Henry Barkley, sen., and Christopher Redick, be Commissioners for expending the same. On the nine mile road between lots number thirty and thirty-one, leading through Williamsburgh and Winchester, the sum of one hundred and sixty pounds; and that John Dix, and Henry Weager, the second, and John Dillibaugh, of Winchester, be Commissioners for expending the same. For building a bridge on lot number thirty-four, in the fifth concession of Williamsburgh, the sum of sixteen pounds, thirteen shillings and four-pence; and that Barnard Whittiker, and John T. Merkeley, be Commissioners for expending the same. On the nine mile road in Williamsburgh, between the fifth and sixth concessions, between lot number thirty-seven and the commons A, the sum of twenty pounds; and that Jacob J. Merkeley, and William Louckes, be Commissioners for expending the same. On the nine mile road between Williamsburgh and Matilda, the sum of ten pounds; and that Gilbert

VanAllin, and Julius Grout, be Commissioners for expending the same. On the nine mile road between lots number six and seven in Matilda, the sum of twenty-five pounds; and that John Flagg, and David Robinson, be Commissioners for expending the same. On the nine mile road between lots number twelve and thirteen in Matilda, the sum of fifty-two pounds, ten shillings; and that Peter Bowan, and John A. Shaver, be Commissioners for expending the same. On the nine mile road through the centre of Matilda and Mountain, the sum of one hundred and sixty-four pounds, three shillings and four-pence; and that Peter Shaver, Peter Boulton, and Peter Smith, be Commissioners for expending the same. On the nine mile road between lots number twenty-four and twenty-five, the sum of fifty-two pounds; and that George Brouse, and Peter Carman, be Commissioners for expending the same. On the nine mile road between lots number thirty-one and thirty-two, the sum of twelve pounds, ten shillings; and that James West, and John Walliser, be Commissioners for expending the same.

XI. *And be it further enacted by the authority aforesaid,* That the sum of one thousand pounds hereby granted to the District of Ottawa, be appropriated and expended as follows, that is to say:—On the road from Point Fortune to the Eastern boundary of the Township of Longueil, the sum of two hundred pounds; and that Charles A. Law, Daniel Wyman, and William Kerby, be Commissioners for expending the same. On the road from the Eastern boundary of the Township of Alfred to the Petit Nation River, on the front road, the sum of two hundred pounds; and that Charles Waters, William Wait, and John O'Brian, be Commissioners for expending the same. On the road from the Petit Nation River to the River Rideau, near Bytown, the sum of two hundred pounds; and that Bradish Billings, Thomas McKay, and John Buchanan, be Commissioners for expending the same. On the road from the County of Glengary to the Ottawa, commencing in the rear of West Hawkesbury, and from thence on the line of said road to the Scotch Church on Van Clack's Hill, the sum of two hundred pounds; and that Peter VanClack, Waters Wells, and Hugh McLaughlin, be Commissioners for expending the same. On the road leading from George Moade's through East Hawkesbury, the sum of fifty pounds; and that Barney VanClack, Simeon S. Eastman, and John Cameron, be Commissioners for expending the same. On the road from Griffin's to Caledonia, the sum of twenty-five pounds; and that Joseph Griffin, Donald McAlpin, and John McMaster, be Commissioners for expending the same. On the road from Chesser's Mills to New Inverness, the sum of twenty-five pounds; and that Alexander McDonell, (Sheriff) John Chesser, and John Paxton, be Commissioners for expending the same. On the road leading through the Town-

On the road from Chesser's Mills to Longueil, commonly called Chesser's road, the sum of fifty pounds; and that Charles P. Treadwell, Elijah Kellogg, and Chancey Johnson, be Commissioners for expending the same.

XII. *And be it further enacted by the authority aforesaid,* That the sum of nineteen hundred pounds hereby granted to the District of Bathurst, be appropriated and expended as follows, that is to say:—On the road from the house of Simon Hogan, in Drummond, to the Town line of Beckwith, the sum of forty-five pounds; and that Sutton Frizell, John Tatlack, and Archibald McGregor, be Commissioners for expending the same. On the road from the Town line of Beckwith to the road leading from Franktown to Carleton Place, the sum of forty-five pounds; and that John Jackson, Alexander McKenzie, and John McDonell, be Commissioners for expending the same. To repair the road through McGregor's Swamp, the sum of twenty-five pounds; and that Archibald McGregor, John McDonell, and John Cameron, be Commissioners for expending the same. On the road from Perth to Hughe's Swamp, on the road to Richmond, the sum of fifty pounds; and that James Boulton, Josias Taylor, and Alexander Fraser, be Commissioners for expending the same. On the road from Hughe's Swamp to Franktown, the sum of fifteen pounds; and that Thomas James, and Phineas Lowe, be Commissioners for expending the same. On the road from the house of Henry Montgomery, to Avery's, in Bathurst, the sum of twenty-five pounds; and that James Young, William McNaughton, and Benjamin Boulton, be Commissioners for expending the same. On the road from Avery's to Boulton's Mills, the sum of fifteen pounds; and that James Ward, and Samuel Walker, be Commissioners for expending the same. On the road from Boulton's Mills to lot number fifteen, in the third Concession of Dalhousie, the sum of fifty pounds; and that John McIntyre, John Armour, and James Robertson, be Commissioners for expending the same. On the road from Balderson's Inn to Freer's Falls, in Drummond, the sum of forty-five pounds; and that Peter Nichol,

Donald Robertson, and George Gould, be Commissioners for expending the same. On the road from the house of George Gould, in Drummond, to Ferguson's Falls, the sum of twenty pounds; and that William Gould, John Richey, and Peter Ferguson, be Commissioners for expending the same. On the road from Ferguson's Falls to Bellamy's Mills, in Ramsay, the sum of forty-pounds; and that Andrew Dickson, Samuel Bellamy, and Alexander McVicar, be Commissioners for expending the same. On the road from Balderson's Inn to the Village of Lanark, the sum of seventy pounds; and that James Maxwell, senior, Matthew Leech, and John Balderson, be Commissioners for expending the same. On the road from Perth to South Sherbrooke, the sum of forty pounds; and that John Nuttal, Patrick Kennedy, and John Millican, be Commissioners for expending the same. On the road from Carleton Place to Pakenham Mills, the sum of fifty pounds; and that Andrew Dickson, William Drynan, and James Bennie, be Commissioners for expending the same. On the road from Lot number Sixteen to Lot number Twenty-four, in the Seventh Concession of Beckwith, the sum of fifteen pounds; and that Duncan Ferguson, James Ferguson, and Finlay McEwan, be Commissioners for expending the same. On the road leading from the Town line of Macnab through Horton, to the Town line of Ross, the sum of twenty-five pounds; and that C. J. Bell, and Thomas O'Neil, be Commissioners for expending the same. From Pakenham Mills to Fitzroy Harbour, the sum of fifty pounds; and that Andrew Dickson, and Alpin McMillan, be Commissioners for expending the same. XIX. *And be it further enacted by the authority aforesaid,* That the sum of two thousand pounds, hereby granted to the District of London, shall be appropriated and expended as follows, that is to say:—On the road leading from the Furnace in Dereham to Port Burwell on Lake Erie, the sum of two hundred pounds, seventy-five pounds of which shall be applied between the Furnace and Talbot road; one hundred and twelve pounds ten shillings, between Talbot Road and the road allowance between the first and second concessions of Bayham, and the remaining twelve pounds ten shillings, between the said road allowance and Port Burwell. On the road allowance between Dunwich and Southwold, from the River Thames to the Dividing Ridge, the sum of twenty-five pounds. On the Tyrconnel Road between lots number twelve and thirteen in Dunwich, from the back street to the River Thames, the sum of twenty-five pounds; and that Leslie Patterson, Esquire, Thomas McCall, and Bray Willy, be Commissioners for expending the same.— On the main road in the Township of Dorchester, the sum of one hundred pounds; and that James Ingersoll, Joshua Putnam, and Gardner Myrick, be Commissioners for expending the same. On the Dundas Street in the Township of London, the sum of twenty-five pounds; and that John Scatchard, Esquire, and Solomon Shenich, be Commissioners for expending the same. On Wharnclyffe Highway, from Michael McLaughlin's to the River Thames, the sum of twenty-five pounds; and that John O'Neil, and Henry Shenich, be Commissioners for expending the same. On the road from the Town of London, passing Black Friars Bridge, the sum of twenty-five pounds; and that John Kent, and Thomas Park, be Commissioners for expending the same. On the road leading from the Commissioners' road in Westminster, to the Town of London, passing O'Neil's Bridge across the Thames, the sum of twenty-five pounds; and that John O'Neil, Albert Odell, and Linus Forbes, be Commissioners for expending the same. From the East line of Carradoc to James Craig's, the sum of twenty pounds; and that Duncan McKenzie, Esquire, James Craig, and Benjamin Woodhull, be Commissioners for expending the same. To Marvel White, and Benjamin Woodhull, to enable them to pay a balance due on a bridge across the River Thames at Woodhull's Mills, the sum of forty pounds. On the road from Benjamin Woodhull's Mills to the residence of Marvel White in Lobo, following that part of the route laid out by Roswell Mount, Esquire, the sum of thirty pounds; and that Marvel White, and Benjamin Woodhull, be Commissioners for expending the same. On the road leading from Finlay Malcolm's to Norwich, the sum of twelve pounds ten shillings; and that Finlay Malcolm, Esquire, John Kelly, and Peter Sackrider, be Commissioners for expending the same. On the road from Whitehead's to the Quaker Meeting House, the sum of fifty pounds; and that George W. Whitehead, Esquire, David Wilson, and George Wright, be Commissioners for expending the same. On the main road from Whitehead's in Burford, to Dodge's in Oxford, the sum of one hundred pounds; and that John Weir, John Kern, and Calvin Martin, be Commissioners for expending the same. On the road from Ingersoll's to Dundas Street, opposite the second concession of Zorra, the sum of twenty pounds. From Thomas Choat's Mills to Dundas Street, twenty pounds. From Peter Hagle's to the Furnace in Dereham, forty pounds. On the Township line between the Townships of Zorra and Nissouri, twenty pounds; and that Hugh McDermid, James Ingersoll, and John Galaway, be Commissioners for expending the same. On Dundas Street, from the Town Plot of Oxford to the Township line of London, the sum of eighty-five pounds; and that Jacob Kearn, Hugh McDermid, and Salmon Vining, be Commissioners for expending the same. On Dundas Street, from Lewis Charles to the Town Plot of Oxford, the sum of fifty pounds; and that John Hatch, Esquire, Joseph Smith, and John Baraclaugh, be Commissioners for expending the same. On the twelfth concession in Zorra, the sum of ten pounds; and that Alanson Harris, and Daniel Mowin, be Commissioners for expending the same. On the road from D. Cross to White's Mills in Zorra, the sum of fifteen pounds; and that R. M. Stitt, and Welcome Yale, be Commissioners for expending the same. On the

In aid to build a bridge across Smith's Creek, between the fourth and fifth concessions in Blenheim, the sum of twenty-five pounds; and that John Jackson, John Daniels, and Thomas Roach, be Commissinners for expending the same. On Dundas Street from the Eastern line of the District of London, West across lot number one in Burford, the sum of ten pounds; and that Michael Showers, Junior, and Elial Martin, be Commissioners for expending the same. On the road from Luke V. Spurs to the Governor's Road, the sum of ten pounds; and that Luke V. Spur, and Benjamin Cole, be Commissioners for expending the same. On the road along the East side of lot number seven, in the seventh concession of Burford, the sum of ten pounds; and that George W. Whitehead, Esquire, and Horatio Fowler, be Commissioners for expending the same. On the road from George Wright's to Cromwell's Mills on the ninth concession of Norwich and Dereham, the sum of ten pounds; and that Francis Stond, and George Wright, be Commissioners for expending the same. On the new road from the Governor's Road, past Lieutenant Brown's to Norwich, the sum of ten pounds. On the road between lots number seven and eight in the Township of Blanford, the sum of ten pounds; and that Edward Buller, Captain Drewe, and Captain Graham, be Commissioners for expending the same. On the main road between Townsend and Woodhouse, leading to Walpole from lot

number seven to Nanticoke Creek, the sum of one hundred and fifty pounds; and that William Wilson, Peter Steinhoff, John Decow, Anthony Upper, James Davis, Benjamin Birdsall, and Mr. Fisk, be Commissioners for expending the same. On the second concession of Woodhouse, from C. McNeillidge's Mills to Walpole line, the sum of one hundred and fifty pounds; and that Colin McNeillidge, Elijah Doan, Jacob Hoover, John Baxter, Michael Graybill, Emanuel Winters, and William Steele, be Commissioners for expending the same. On the side line between lots number six and seven in the Township of Woodhouse, from the fourth concession to the Township line between Woodhouse and Townsend, the sum of forty pounds; and that Phillip Austin, and John Parks, be Commissioners for expending the same. On the town line between Windham and Townsend, from Lang's Saw Mill to the corner of Burford, the sum of forty pounds; and on the eleventh concession of Townsend, the sum of fifteen pounds; and on the eleventh concession of Windham, the sum of thirty pounds; and that Israel W. Powell, Esquire, John Robbins, Jacob Langs, and Phillip Beamer, be Commissioners for expending the same. On the road in Boston settlement, from the Baptist Meeting House, through by Milford Mills to Oakland, the sum of twenty pounds; and that Aaron Barber, and Uriah Corlis, be Commissioners for expending the same. On the Talbot Road in Middleton, from Sovereign's to Coltman's, the sum of ten pounds; and that Frederick Sovereign, and Tisdale Parley, be Commissioners for expending the same. On the Town line between Charlotteville and Walsingham, from the first concession to the Lake, the sum of twenty pounds; and that Jacob Potts, Esquire, and William Backhouse, be Commissioners for expending the same. On the road from the sixth to the eighth concession of Charlotteville, thence along the eighth concession to James Blaney's, the sum of fifteen pounds; and that Aquilla M. Walsh, and Henry Sovereign, be Commissioners for expending the same. On the Lake road in Houghton, from the Walsingham line to the plains, the sum of ten pounds; and that Edward Foster, and Thomas Burgar, be Commissioners for expending the same.

XX: *And be it further enacted by the authority aforesaid,* That the sum of one thousand seven hundred pounds, granted to the Western District, be appropriated and expended as follows, that is to say:—For opening one rod wide and bridging the middle road between Talbot road and the River Thames, through the Townships of Maidstone, Rochester and West Tilbury, and from the division line between West and East Tilbury to lot number twenty-four in the last mentioned Township,

On the communication road in the Township of Harwich, the sum of one hundred pounds; and that Duncan McGregor, and James W. Little, Esquires, and Mr. Robert Wood, be Commissioners for expending the same. On the road between Dover and Chatham to Big Bear Creek, the sum of fifty pounds; and that Duncan McGregor, Esquire, and Messieurs Pierre Paul La Croix, and Laughlin McDougall, be Commissioners for expending the same. On the road along the River Saint Clair, in the Township of Sombra, and the Indian Reservation adjoining the said Township, the sum of twenty pounds; and for the road along the said River Saint Clair, in the Township of Moore, the sum of thirty pounds; and that William Jones, Claud Gouin, Esquires, and Mr. Louis Rendt, be Commissioners for expending the same. On the Talbot Road in the five mile woods, in the Township of Romney, the sum of twenty pounds; and on the road passing between the farms of Joseph Klinansmith, and Joseph Smith, in Raleigh, leading to the settlement on the middle road in the said Township, the sum of fifty pounds; and that James W. Little, Joseph Smith, and Thomas Renwick, be Commissioners for expending the same. On the road between lots number ninety-one and ninety-two in the Township of Howard to the Lake shore, the sum of twenty-five pounds; and that Messieurs Robert Wood, and John Unsworth, be Commissioners for expending the same. On the road dividing the Townships of Chatham and Camden from the River Thames, through Dawn, to the East branch of Bear Creek; the sum of forty pounds; and that George Kirby, Esquire, Christopher Arnold, and William Wallen, be Commissioners for expending the same. Towards erecting a Draw-Bridge across the River Thames, from the Town of Chatham, in the Township of Harwich, to the Township of Chatham, at such place as may be fixed upon by the Justices in General Quarter Sessions in the said Western District assembled, the sum of two hundred and fifty pounds; and that John Dolson, and Duncan McGregor, Esquires, and Lewis Arnold, the elder, be Commissioners for expending the same: provided that the said sum of two hundred and fifty pounds shall not be paid to the said Commissioners, until they shall have proved to the said Justices in Quarter Sessions assembled, that a sufficient additional sum of money shall have been provided to complete the said Bridge. On the Sandwich Talbot road, from Sandwich to Good-

body's farm, the sum of twenty-five pounds; and from lot two hundred and ninety-six to two hundred and eighty-two, inclusive, the sum of one hundred and forty pounds; and that George Jacob, Charles Askin, and Chrysostom Pajot, Esquires, be Commissioners for expending the same. On the said Sandwich Talbot road, from lot number two hundred and sixty to two hundred and sixty-four, inclusive, the sum of seventy-five pounds; and that John Fulmer, Eliakim Field, and George Bruner, jun. be Commissioners for expending the same. On the Talbot road in Mersea, East of Hairsign's, the sum of fifty pounds; and that Francis Wilkinson, Daniel McKenzie, and Charles Hairsign, be Commissioners for expending the same. On the concession roads in Gosfield, the sum of twenty-five pounds; and that Peter Scratch, John Scratch, and Joseph Wigle, be Commissioners for expending the same. On the allowance for road between the East and West divisions of Gosfield, from Lake Erie to Talbot Road, the sum of twenty-five pounds; and that John Scratch, John Wigle, and Prideaux Girty, be Commissioners for expending the same. On the new road in Colchester, authorised at the last October Sessions, the sum of fifty pounds, to be laid out from John Little's to Beaman's; and that Alexander McCormick, Thomas Wright, and Adam Fox, be Commissioners for expending the same. On the concession roads in Colchester, the sum of twenty-five pounds; and that Jarius Brush, Mathew McCormick, and James Lockart, be Commissioners for expending the same. On the Malden road, from Amherstburgh to the Sandwich Talbot road, for bridging the same, the sum of one hundred pounds; and that James Caldwell, William McGee, and Charles Berczy, Esquire, be Commissioners for expending the same. On the road from the East side of Rochester to Lavallee's, along Lake Saint Clair, the sum of twenty-five pounds; and that Benjamin Lavallee, Charles Campeau, and James Askin, be Commissioners for expending the same. On the road from Detroit River to the second concession, between Lauzon's and Campeau's farm, the sum of twenty-five pounds; and that Antoine Cecile, and James Dore Langlois, be Commissioners for expending the same. On the new road from Jacob Shaffer's, above Pike's Creek, to the second concession line of the Township of Sandwich, and along the same to Andre Peltier's, the sum of eighty-eight pounds; and that Benjamin Lavallee, Charles Campeau, and James Askin, be Commissioners for expending the same. Toward turnpiking the road on the Huren Reserve, from Bazil Drouillard's to the River Aux Canards, the sum of ten pounds; and that Laurent Bondy, and Francois Monfreton, be Commissioners for expending the same. On the road between the Townships of Howard and Harwich, the sum of sixty-two pounds; and that Robert Wood, John Unsworth, & Christopher Arnold, be Commissioners for expending the same. On the roads between lots number eighty

six and eighty-seven, in the Township of Howard, from Talbot road to the shore of Lake Erie, the sum of forty pounds; and that David S. Baldwin, and John Unsworth, be Commissioners for expending the same. Towards repairing the bridge across the River Thames, from Camden to Howard, the sum of one hundred pounds; and that Christopher Arnold, and George Kirby, Esquire, be Commissioners for expending the same. On the road in Gosfield, from Jonas Fox's to the Furnace, the sum of twenty-five pounds; and that Jonas Fox, and Eliakim Field, be Commissioners for expending the same.

Commissioners to make a return on oath of the monies expended by them respectively.

XXI. *And be it further enacted by the authority aforesaid,* That some one of the Commissioners hereinbefore named or appointed under the authority of this Act, for any division of road, shall and he is hereby required to make an Oath before some one of the Justices of the Peace in the District in which such Commissioner or Commissioners shall act, and annex or subjoin the same to the Schedule or Abstract Statement of the expenditure of the Monies under the direction of such Commissioner or Commissioners, in the following form:—

Form of oath.

I, A. B. a Commissioner under the Road Act, make Oath and say, that the prefixed Schedule or Abstract Statement is a true and faithful account, in all its particulars, of the Monies expended by the Commissioners, of which I am one, to the best of my knowledge and belief.—  
So help me God.

Receiver General to pay monies to the Treasurers of the several Districts, to be accounted for through the Lords of the Treasury.

XXII. *And be it further enacted by the authority aforesaid,* That any Monies to be laid out and expended under the provisions of this Act, shall be paid by the Receiver General to the Treasurers of the several Districts, in discharge of such Warrant or Warrants as shall be issued for that purpose by the Governor, Lieutenant Governor, or Person Administering the Government of this Province for the time being, and shall be accounted for to His Majesty through the Lords Commissioners of His Majesty's Treasury, in such manner and form as His Majesty, His Heirs or Successors shall be graciously pleased to direct.

Treasurers to pay monies to Commissioners so soon as contracts shall have been made and the work commenced.

XXIII. *And be it further enacted by the authority aforesaid,* That the Treasurers of the several Districts are hereby authorised and required to pay over to the Commissioners named in this Act or appointed under the authority thereof, or a majority of them, so soon as contracts shall have been made for the expenditure thereof and the work shall have been commenced, the several sums by this Act appropriated to be expended on that portion of the Roads which such Commissioners are appointed

ted to superintend: *Provided always*, that the said Treasurers shall not be entitled to any Commission for receiving and paying the several sums mentioned in this Act.

XXIV. *And be it further enacted by the authority aforesaid*, That in the event of the death, removal, or refusal to act, of any of the Commissioners named in this Act, it shall and may be lawful for the Governor, Lieutenant Governor, or Person Administering the Government of this Province for the time being, to appoint such person or persons as he shall think fit to fill the vacancies that may be occasioned as aforesaid.

Vacancies among the Commissioners may be filled up by the Lieutenant Governor.

XXV. *And be it further enacted by the authority aforesaid*, That the Monies hereby authorised to be expended upon the roads in the several Districts of this Province, shall be expended and applied on or before the fifteenth day of August next, after the passing of this Act: *Provided always*, that nothing herein contained shall apply to the construction of Bridges or Causeways not required to be covered with earth.

Monies to be expended by the 15th August, except so far as relates to bridges and causeways.

XXVI. *And be it further enacted by the authority aforesaid*, That it shall be the duty of the Commissioners hereinbefore mentioned, and they are hereby required in all cases where improvements are to be made upon the Roads and Bridges throughout the several Districts of this Province, to expose the same at Public Auction, and in small portions where it may be practicable, so as to afford ample competition to all persons desirous of contracting for portions of the work to be performed, and to strike off the same in convenient portions to the lowest bidder, having in all cases given at least three weeks previous notice thereof by public advertisement, or to procure the performance of such improvements or repairs, in such manner as the majority of such Commissioners shall deem most advantageous and expedient: *Provided always*, that no Commissioner hereinbefore named shall be a Contractor for any part of the work over which he shall have been appointed such Commissioner.

How contracts to be let.

XXVII. *And be it further enacted by the authority aforesaid*, That it shall be the duty of the Commissioners hereinbefore named, or that may be appointed under the authority of this Act, and they are hereby required to make out, and at the time of paying over any monies, cause to be executed in the presence of at least one credible witness, vouchers or pay lists containing abstract statements of the monies expended and the service performed, stating the names of the several Contractors, the pieces of work performed, the rate at which such work shall have been performed, and the signatures of the Contractors, acknowledging the receipt of the sums opposite their names respectively; which vouchers

Commissioners to make out pay lists of monies expended, and cause the same to be signed in presence of a witness.

Vouchers to be delivered to the Treasurers, together with any balance remaining unexpended. Treasurers to transmit returns to the Governor's Office by the 30th November. to be laid before the Assembly, and all balances of money to be repaid to Receiver General.

shall be made according to the annexed Schedule or Form, and together with any balance remaining unexpended, delivered to the Treasurers of the several Districts, who shall cause such returns to be transmitted to the office of the Governor, Lieutenant Governor, or person Administering the Government, on or before the Thirtieth day of November next, and be by him laid before the Commons House of Assembly, and such balances to be repaid to His Majesty's Receiver General, to be accounted for as a part of the General Revenues of this Province.
