An Act for the appropriation of the Revenues arising from the Jesuits' Estates, for the year one thousand eight hundred and forty-six.

[9th June, 1846.]

HEREAS it is expedient to provide by Act of the Parliament of this Province, Freemble. for the application of the revenues and interest arising from the Estates of the late Order of Jesuits to Educational purposes in Lower Canada, and to appropriate certain sums out of the same for such purposes during the present year: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled, An Act to re-unite the Provinces of Upper and Lower Canada, and for the Government of Canada, and it is hereby enacted by the authority of the same, That the revenues and interest Revenues and arising from the real or funded property forming part of the Estates of the late Order of Jesuits, and now at the disposal of the Legislature for Educational purposes in that suits' Estates, part of this Province which formerly constituted the Province of Lower Canada, shall to be applied to Educational be and are hereby declared to be applicable to such purposes, and to no other; and that purposes in Lower Canada from and out of the said revenues and interest there shall be paid for and during the Appropriation for 1840. the Schedule annexed to this Act, for the purposes therein expressed.

II. And be it enacted, That the due application of the monies hereby appropriated Accounting shall be accounted for to Her Majesty, Her Heirs and Successors, through the Lords clause. Commissioners of the Treasury for the time being, in such manner and form as Her Majesty, Her Heirs and Successors shall be pleased to direct.
