CAP. XXIV.

An Act to Incorporate the Charitable Association of the Roman Catholic Ladies of Quebec.

[12th October, 1842.]

Preamble.

HEREAS an Association for the purpose of affording relief to destitute Orphans and of imparting sound moral and religious instruction to Fe-Orphans and of imparting sound moral and religious instruction to Female children generally, hath existed for some years in the City of Quebec, and hath already educated a great number of Orphans and provided for their maintenance, until they were able to maintain themselves; and whereas the persons hereinafter named being members of the said Association have by their petition represented that the advantages resulting from the Association would be greatly increased, if the members thereof were incorporated under proper regulations, and have prayed to be incorporated accordingly, and it is expedient to grant the prayer of their petition for the purpose of encouraging the laudable efforts of the said Association and promoting the Public advantages which must arise from the same; Be it therefore enacted, by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled, An Act to Re-unite the Provinces of Upper and Lower Canada, and for the Government of Canada, and it is hereby enacted by the authority of the same, that M. CAP. XXV.

An Act to extend the powers of the British America Fire and Life Assurance Company, to Marine Assurances.

[12th October, 1842.]
