### CAP. VIII.

## An Act to continue for a limited time the several Acts and Ordinances therein mentioned.

### [ 28th July, 1847. ]

HEREAS it is expedient to continue for a limited time the several Acts and Preamble. Ordinances hereinafter mentioned: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and of the Legislative Assembly of the Province of Canada, constituted and assembled by virtue of and under the authority of an Act passed in the Parliament of the United Kingdom of Great Britain and Ireland, and intituled, An Act to re-unite the Provinces of Upper and Lower Canada, and for the Government of Canada, and it is hereby enacted by the authority of the same, That the Act of the Legislature of the Province of Canada, passed in the seventh year of Her Majesty's Reign, and intituled, An Act to repeal 7 Vict. c. 10. an Ordinance of Lower Canada, intituled, 'An Ordinance concerning Bankrupts and the administration and distribution of their estates and effects, and to make provision for the same object throughout the Province of Canada,' as amended and extended by the Act passed in the ninth year of Her Majesty's Reign, and intituled, An Act to continue and amend the Bankrupt Laws now in force in this Province, and the said last mentioned Act shall remain in force until the first day of January which will be in the year of Our Lord one thousand eight hundred and forty-eight, and thence until the end of the then next Session of the Provincial Parliament, and no longer.

II. And be it enacted, That the Act of the said Legislature, passed in the eighth year of Her Majesty's Reign, and intituled, An Act for the better preservation of the Peace 8 Vict. c. 6, and the prevention of Riots and violent outrages at and near Public Works while in pro- continued. gress of construction, shall remain in force until the first day of January, which will be in the year of Our Lord one thousand eight hundred and forty-eight, and thence until the end of the then next Session of the Provincial Parliament, and no longer.

III. And be it enacted, That the Act of the said Legislature, passed in the eighth year of Her Majesty's Reign, and intituled, An Act to amend the Act and Ordinance 8 Vict. c. 27, therein mentioned, relative to the Registration of Titles to and Incumbrances upon Real Property in Lower Canada, shall remain in force until the first day of January, which will be in the year of Our Lord one thousand eight hundred and forty-eight, and thence until the end of the then next Session of the Provincial Parliament, and no longer.

And be it enacted, That the Act of the said Legislature, passed in the year last aforesaid, intituled, An Act to enable the Inhabitants of the Seigneurie of La Baie Saint Antoine, commonly called La Baie du Febre, to provide the better regulation of the Common in the said Seigneurie, as extended by the Act of the said Legislature passed in the fourth year of the same Reign, and intituled, An Act to authorize the Chairman and Trustees of the Common of the Seigniory of the Baie Saint Antoine, commonly called The Baie du Febre, to terminate certain disputes relating to the limits of the said Common, and for other purposes appertaining to the same, and the said last mentioned Act shall remain in force until the first day of January, which will be in the year of Our Lord one thousand eight hundred and forty-eight, and thence until the end of the then next Session of the Provincial Parliament, and no longer.
